COUNTERCLAIM

NOW COMES Defendant/Counter-Plaintiff Ocean Rock Bath, LLC, by and through its attorneys, Shifman & Carlson, P.C., and for its counterclaim against the Plaintiff/Counter-Defendant Robert Anderson, states as follows:

GENERAL ALLEGATIONS

- Defendant/Counter-Plaintiff Ocean Rock Bath L.L.C. ("Ocean Rock")
 is a company with a registered mailing address at 35334 Park St., Richmond,
 Michigan 48062.
- 2. Plaintiff/Counter-Defendant Robert Anderson ("Anderson") is an individual residing at the address 21537 Tanglewood, St. Clair shores, MI 48082.

- 3. This Court has subject matter jurisdiction over Ocean Rock's claim pursuant to 15 U.S.C. § 1121, 28 U.S.C. § 1331, and 28 U.S.C. § 1338.
- 4. This Court has personal jurisdiction over the Anderson, because Anderson has (a) committed intentional and tortious acts within the State of Michigan; and (b) maintained an interactive website that permits the exchange of information between users in the State of Michigan and the Defendant, including specifically advertised in the area around Detroit, Michigan; and (c) otherwise has purposefully availed itself of this forum.
- 5. Venue is proper in this Court pursuant to 28 USC § 1391 because a substantial part of the events or omissions giving rise to Ocean Rock's claim occurred in this judicial district and because Anderson was subject to personal jurisdiction within this judicial district at the time the action was commenced.

General Allegations

6. Anderson runs a small business, Detroit Tubs, LLC ("Detroit Tubs"), that performs various tub related services including bathtub porcelain refinishing, conversion of tubs to showers, and the installation of walk-in or step-in tubs. Anderson currently runs a website advertising his services at detroittubs.com and at 5862961100.com.

- 7. On or about November 18, 2019, Detroit Tubs and Defendant Nick Doelle ("Doelle") entered an arrangement utilizing Doelle's services as an independent contractor.
- 8. Doelle later terminated his relationship with Detroit Tubs and organized his own company, Ocean Rock, on or about June 21, 2022. Ocean Rock specializes in refinishing bathrooms, but specifically does not perform the same sort of bathtub porcelain refinishing or tub conversion services offered by Detroit Tubs.
- 9. To advertise its services, Ocean Rock runs the website www.oceanrockbath.com. Exhibit A.
- 10. Perturbed by Doelle's departure, Anderson commenced a civil case against Doelle and Ocean Rock on or about April 27, 2023, which case is still ongoing under case number 2023-001402-CB in the Macomb County Circuit Court.
- 11. Anderson also purchased the domain name www.oceanrockbaths.com (the same website as Ocean Rock but with an "s" on the end), which used the same images, font, and symbols as Ocean Rock's website. The website was substantially the same, save for the addition of a text box titled, "THE TRUTH ABOUT NICK DOELLE," which was followed by a diatribe against Doelle and his ability as a contractor. See Exhibit B, Screenshot.
- 12. Anderson's website, which purposefully modeled itself on Ocean Rock's website and includes its logo and brand name, also featured an additional tab

by which customers could purchase Anderson's services thinking that they were hiring Doelle. See Exhibit B, pages 4-6.

- 13. On or about July 22, 2023, counsel Ocean Rock sent a takedown request under the Digital Millenium Copyright Act ("DMCA"), requesting that Anderson's website be removed for violating Ocean Rock's copyright.
- 14. On or about July 26, 2023, counsel for Ocean Rock received an email noting that the website host had asked Anderson to take down the website www.oceanrockbaths.com within two (2) days.
 - 15. Anderson failed to comply, and his account was suspended.
- 16. Although Anderson's www.oceanrockbaths.com was taken down, Anderson has since created another website at www.truthaboutnickdoelle.com, which warns current and potential clients of Doelle and Ocean Rock to "stay away" and that Anderson is suing Doelle in state and federal court.
- 17. Upon information and belief, Anderson continues to own the web address oceanrockbaths.com.

Cybersquatting under the Anticybersquatting Consumer Protection Act – 15 USC 1125(d)

- 18. Ocean Rock restates and incorporates the foregoing allegations as though fully restated herein.
- 19. Anderson registered, trafficked in, or used the "oceanrockbaths.com" domain name with a bad-faith intent to profit from Ocean Rock's OCEAN ROCK BATH mark and goodwill associated therewith.
- 20. Ocean Rock's OCEAN ROCK BATH mark was distinctive at the time Anderson registered, trafficked in, or used the <oceanrockbaths.com> domain name.
- 21. Anderson was the registrant or the registrant's authorized agent or user of <www.oceanrockbaths.com>.
- 22. Anderson's registration of the www.oceanrockbaths.com domain, occurred after Ocean Rock had started his website and was specifically modeled to imitate Ocean Rock's website, indicating that Anderson had actual notice of Ocean Rock's trademark rights in OCEAN ROCK BATH.
- 23. The <oceanrockbaths.com> domain names are each identical or confusingly similar to Ocean Rock's OCEAN ROCK BATH mark.
- 24. The <oceanrockbaths.com> domain name does not consist of the legal name of Anderson or his company, Detroit Tubs LLC.

- 25. Anderson registered and used the domain name <oceanrockbaths.com> with the intent to divert customers from Ocean Rock for Anderson's commercial gain by creating a likelihood of confusion as to the source, sponsorship, affiliation, or endorsement of the website.
- 26. Anderson used the domain name <oceanrockbaths.com> with a bad faith intent to profit from the acquisition of and delivery of leads to Anderson's benefit.
- 27. Anderson's registration, use, or trafficking in the coceanrockbaths.com domain names constitutes cybersquatting in violation of 15 U.S.C. § 1125(d), entitling Ocean Rock to relief.
- 28. By reason of Anderson's acts alleged herein, Ocean Rock's remedy at law is not adequate to compensate them for the injuries inflicted by Anderson. Accordingly, Ocean Rock is entitled to preliminary and permanent injunctive relief pursuant to 15 U.S.C. § 1116.
- 29. By reason of Anderson's acts alleged herein, Ocean Rock is entitled to recover Anderson's profits, actual damages, and the costs of the action, or statutory damages under 15 U.S.C. § 1117, on election by Plaintiff, in an amount between One Thousand dollars (\$1,000) and One Hundred Thousand dollars (\$100,000) for cybersquatting, as the Court considers just.

30. This is an exceptional case making Ocean Rock eligible for an award of attorney's fees under 15 U.S.C. § 1117.

PRAYER FOR RELIEF

WHEREFORE, Ocean Rock requests that this Court enter judgment against Plaintiff/Counter-Defendant Anderson as follows:

- A. That the Court issue temporary and permanent injunctive relief against Plaintiff/Counter-Defendant Anderson, and that Plaintiff/Counter-Defendant Anderson and any of his agents, representatives, servants, employees, attorneys, successors and assignees, and all others in active concert or participation with Plaintiff/Counter-Defendant Anderson, be enjoined and restrained from:
 - registering, using, or trafficking in any domain name that is identical or confusingly similar to Ocean Rock's OCEAN ROCK BATH mark, including, but not limited to, the <oceanrockbaths.com> domain name;
 - ii. infringing Ocean Rock's trademarks and service marks, including theOCEAN ROCK BATH mark; or
 - iii. assisting, aiding, or abetting any other person or business entity from infringing Ocean Rock's trademarks or service marks, including the OCEAN ROCK BATH mark.

- B. That the Court order the transfer of the <www.oceanrockbaths.com> domain name, and any other confusingly similar domain name registered or used by Anderson, to Ocean Rock;
- C. That the Court award Ocean Rock statutory damages in the amount of \$100,000;
- D. That the Court award Ocean Rock its attorneys' fees and costs; and
- E. That the Court grant Ocean Rock all other relief to which it is entitled and such other or additional relief as is just and proper.
